Thames Row Issues:

Thames Row Boundary Wall MF mentioned that wall is showing further signs of cracking

MB agreed that Reddingtons would conduct regular laser measures of this wall to establish any further movement Cracking will be repaired, and the wall will be rebuilt where it has been removed completely

Thames Row Access Visibility Mirror has been installed, and has improved visibility.

Thames Row Planting Beds MB advised LM that due to the return of scaffolding in January, it was not wise to replant the Thames Row side bed

This will be reinstated, possibly with stock from the 42KBR landscapers, on completion of all the works

LM agreed that potted plants would be kept there in the interim

42 KBR Planting Plan MF raised the issue of the LPA approved planting plan for the courtyard, and discussions with the planning officer

(MF also sent on follow up email after the meeting: this approval appears to be pending)

Lighting on Thames Path MB advised that council were aware of change in scaffold status, and would be dealing with this

JM advised that he would prefer the existing sodium lights to remain there for as long as possible

MF queried whether new LED Thames Path streetlights, missed out because of scaffolding, were to be replaced

<b>42 KBR</b> Regatta Point Issues Shared Wall RP/42 KBR	Meeting 28 August 2014
1. Noise transfer	DN again raised issue of noise transfer between balcony of 42KBR and RP main building His concern is in respect of South East corner, i.e. the fabric of the RP building itself
2. Balconies	MB advised that he would need to pursue this with RP directly, as it was outside his remit for the 42KBR works The positioning of the balconies was discussed, but it is unclear from the existing drawings how they communicate across the two buildings, although the 42KBR balconies appear about 500mm higher than the RP ones The 42KBR ones will also extend beyond the line of the RP building
2. Regatta Point Mural	The integrity of the mural was raised again: MB reiterated that it was 'live' and the mural unstable. This has no bearing on the integrity of the shared wall itself
